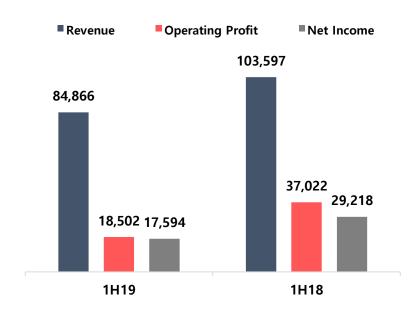

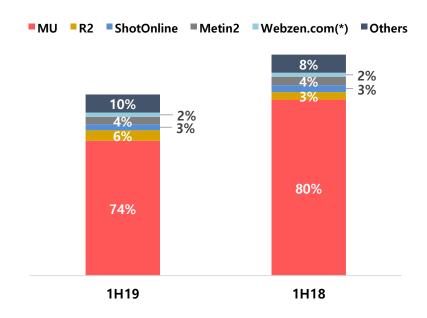

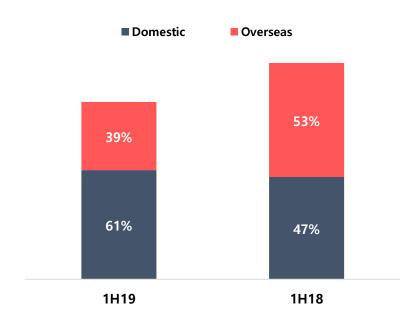

Sales breakdown



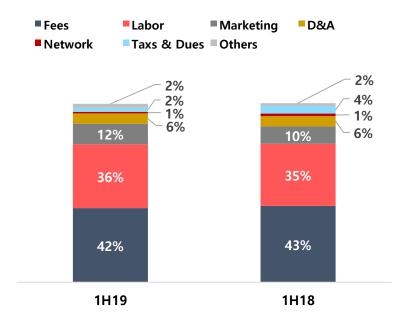

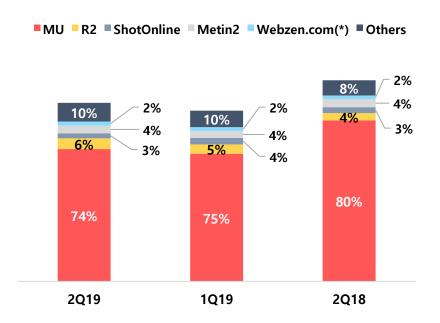

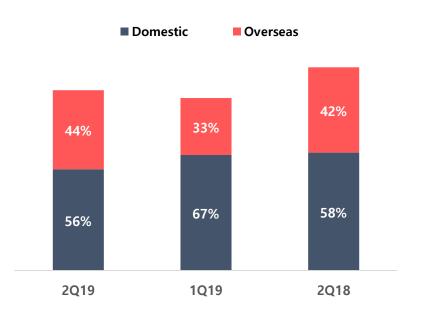

Sales breakdown



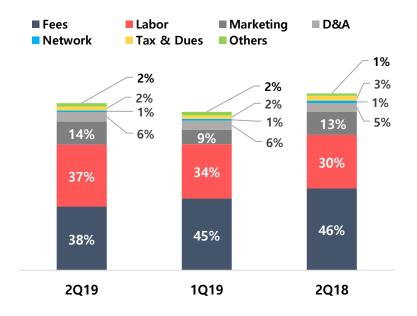
