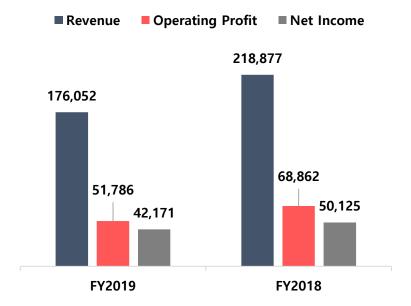


■ Revenue 176.1b (YoY \(\pm 20\)%)

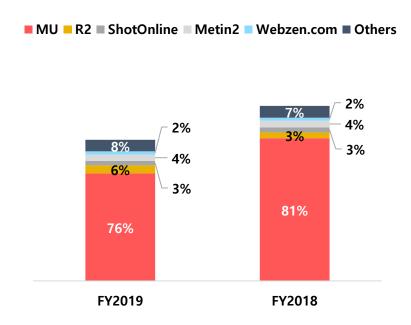

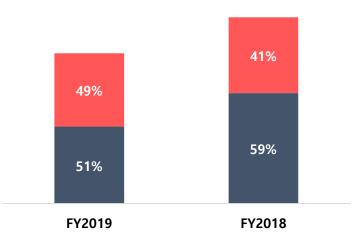

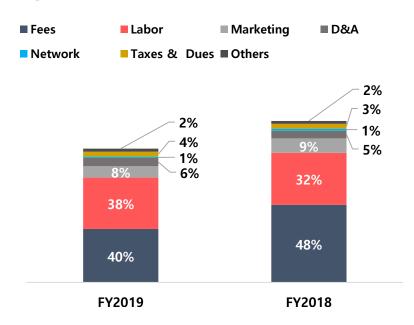
