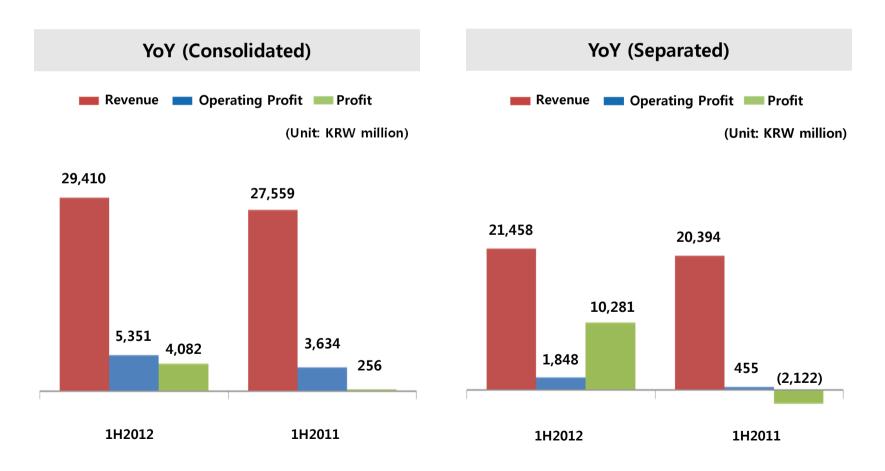

#### **Results Analysis**



- ▶ Revenue: YoY ↑ 7% based on consolidated, YoY 5% ↑ based on separated
- ▶ Operating Profit (Loss): YoY ↑ 47% based on consolidated, YoY 307% ↑ based on separated
- ▶ Profit (Loss): YoY ↑ 1,492% based on consolidated, YoY turned surplus based on separated

- MU 9.1 bil (YoY 14% ↑) , SUN 2.2 bil (YoY 15% ↓)
